March 29th: National Vietnam Veterans Day

On March 29, 1973, the last of our troops left Vietnam. Three million Americans served in the conflict and thousands upon thousands returned home with physical and emotional wounds. More than 58,000 others never returned home, laying down their lives in service to our nation.

Our Vietnam War Veterans, whether in country or not, were scorned and insulted by vociferous antiwar activists. Many of those protestors have come to realize the negative effect their actions caused and are working hard to make amends. So today, while opposition to the conflicts and continued troop presence in Afghanistan and Iraq is fierce, support and respect for our troops is widespread. While service members today often travel in uniform, a uniform that today elicits high esteem from the public, Vietnam War veterans often traveled in civilian clothes to avoid verbal attacks and the like.



To Washingtonians who served during the Vietnam War, thank you, truly, thank you for your service. To those of you who have family members who served during that time, hug them a little tighter or give them a call if they are far, as the late 60's and 70's were tough times for them. Many were able to put that time behind, but others, while they physically came home, are still missing in action emotionally. This is why our WDVA efforts to connect all veterans and their families to their earned benefits are critical to finally bring our Vietnam brothers and sisters home.

Base Access: Documents Needed for Enhanced License

Wondering what documents you'll need to obtain your Enhanced Drivers License (EDL) to travel onto Washington state military bases? Take a look at the requirements from Washington State Department of Licensing and don't wait until it's too late! Visit www.dol.wa.gov for more information



What documents do I need to get my EDL/EID?

This list will help you meet the requirements to get an enhanced driver license (EDL) or enhanced identification card (EID). We can only accept original documents or government-certified copies with a raised seal or stamp. We cannot accept internet printouts, temporary, uncertified, notarized, or altered documents. We may retain copies of any documents you bring.

If you have a Washington driver license or identification card with a photo, you will need to bring the following when you go to a driver licensing office:

1. Proof of United States citizenship
2. Social Security number

If you do not have a Washington driver license or identification card with a photo, bring:

1. Proof of United States citizenship
2. Social Security number
3. Proof of identify
4. Proof of Washington State residence

Proof of United States citizenship

To prove citizenship, show us one of the following:

- United States Passport that is valid or has been expired no more than five years
- Valid United States Passport card
- Original certified* state birth certificate (issued by the city, county, or state)
- Certificate of naturalization
- Certificate of citizenship
- Department of State Consular Report of Birth Abroad
- Valid out-of-state enhanced license or ID

* A certified birth certificate has a registrar's raised, embossed, impressed, or multicolored seal; a registrar's signature; and the date it was filed with the registrar's office, which must be within one year of your birth.

Social Security number

Be prepared to tell us your Social Security number. You don't need to show us the card. Your name and Social Security number must match Social Security records.

Proof of identity

Show one of the following:

- Valid United States Passport
- Valid state-issued driver license, enhanced driver license, or ID card
- Military ID
- Government employee ID card (state, federal, or city) showing your name and signature
- Tribal identification card

Proof of Washington State residence

To prove you live in Washington, show us **one document from this list with your name and current Washington resident address.**

- Concealed weapons permit
- Homeowner's insurance policy or invoice showing the address of the insured property or residence
- Home utility bill (such as gas, electricity, water, garbage, or land line telephone, or cable) or hook-up work order dated within the past 60 days. You must be the only person named on the bill or work order.

Vet Bikes & Building 9 for Veterans

Building 9 for Veterans Transitional Housing Program is located at the Washington Veterans Home in Retsil, WA.

The 60-bed transitional housing facility is available to assist those in need of stable housing, vocational rehabilitation, and increased income potential.

Veterans are surrounded with supportive staff and wrap-around services designed to lead to their successful completion of the program and to the community.

Building 9 for Veterans is also the home of the Vet Bikes Program's main bike shop, which is a veteran run 501c3 non-profit providing adaptive sports bicycles to recovering veterans in the Washington and Colorado state areas.

While a bicycle can be adapted to meet unique needs of a physically disabled veteran, the vast majority of our referrals and requests come from disabilities that cannot be seen, and do not always require a bike heavily adapted to help in the treatment of their disability.

VetBikes is dedicated to cycling sport therapy and offers recovering disabled veterans a path where the supported veterans can rise, and have risen, from introductory levels to international competition.

The comprehensive program offers bicycle ownership, placement with local cycling clubs for community integration, sporting mentors, professional mechanical instruction, and an introductory path to a career in the cycling industry. The mission is proudly supported by a wide range of sponsors and partner organizations.

Here at the WDVA Building 9 for Veterans, clients staying at the home volunteer in the bike shop and learn the bike mechanic trade, while also serving their fellow veterans.

Building 9 for Veterans has also successfully referred hundreds of veterans to the program ensuring better quality of life for those with disabilities.

It is quite the sight to see veterans riding around all over our campus in bikes that they are proud to use and OWN!

WDVA Receives Combined Fund Drive's (CFD) Highest Participation Percentage

The Washington State Department of Veterans Affairs was recognized by the Secretary of State's Combined Fund Drive Office for 2015's Highest Participation Percentage from a Large Agency at 46.82%. WDVA staff contributed \$15,285.65 to charities in their communities. Of that \$3,918.75 was raised to provide support to homeless veterans.

Orting Wins 2016 Energy Savings Program



And the Winner Is: Washington Soldiers Home. Orting is the winner in the energy savings program for 2015. Our Facilities Department has done an OUTSTANDING job in reducing energy by using boiler time based on needs not just run time, more preventative maintenance on systems in the buildings, etc.

The 2015 Battle of the Buildings final report has been submitted. Our weather normalized site energy savings in 10 facilities was about 15 million kBtu's, reducing annual energy use by 9 percent!

Here is a quick summary of the weather normalized site energy savings:

- 27% DVA Washington Soldiers Home**
- 15% ECY Bellingham Field Office**
- 15% Pierce Ft. Steilacoom Campus**
- 6% Pierce Puyallup Campus**

Also they are about 90 days away from reaching 365 days without a time loss injury. June 10th will be the one year mark.

2016 Legislative Session Review



The **2016 Regular and Special Session** has come to a close and several important pieces of legislation will be enacted in June. Below is a recap, but visit <http://www.dva.wa.gov/about-wdva/legislative-updates> for a more in-depth review.

ESHB 1213 County veterans assistance fund:

Modifies the definitions of "veteran" and "family" for the purposes of the Veterans' Assistance Fund. Deletes references to RCW 41.04.005 and .007. Gives Counties the ability to pass bylaws so that

they can expand eligibility for the fund. Effective 6/9/2016

ESHB 1351 National Guard hunting license: Requires the Washington Department of Fish and Wildlife to issue three types of recreational hunting licenses to resident full-time members of the Washington State Guard and National Guard at no charge. Effective 6/9/2016


HB 2637 Historic cemetery preservation: Creates the Washington state Historic Cemetery Preservation Capital Grant program in the Department of Archaeology and Historic Preservation. \$50,000 grants may be awarded biennially, subject to appropriation. Effective 6/9/2016

E2SHB 2793 Suicide education: Establishes a Safe Homes Task Force (including WDVA participation) to develop suicide awareness and prevention education messages and training and implement advocacy efforts with key stakeholders to pair suicide prevention training with distribution of devices for safe storage of lethal means. Effective 6/9/2016

SB 6202 National Guard employment rights: Requires the Attorney General to take enforcement action to protect a state service member's employment rights after the Adjutant General has attempted to resolve the matter with the employer. Effective 6/9/2016

SSB 6254 Purple Heart license plates: Allows individuals qualified to display Purple Heart special license plates to purchase additional plates for use on more than one motor vehicle. Additional funds are deposited into the Stewardship account to be used for the State Veterans Cemetery and homeless veteran services. (Effective date not available at time of printing)

SB 6405 Civilian health program: Exempts the Civilian Health and Medical Program for the Department of Veterans Affairs (CHAMPVA) from the definition of "health plans." Permits CHAMPVA coverage to be offered to groups other than to those set forth in statute. (Effective date not available at time of printing)
